COURSE CALENDAR STATEMENT:

An introduction to Greek and Roman myths as presented in classical literature and art, and to their cultural context.

COURSE DESCRIPTION:

An introduction to Greek and Roman myths as presented especially in Greek and, to a lesser extent, in Roman literature. There will be some discussion of the representation of myth in ancient art. There will be considerable discussion of myth within its historical and context.

For online courses:

This course will take place **online** via Desire2Learn (D2L). It is asynchronous. Audio lectures will be placed online (D2L) more or less following the timetable indicated on the Schedule of Lectures (posted separately on D2L). The audio lectures will be supported by PowerPoint slides.

3. understand the role of mythology within the classical world and its literature;

5. articulate the importance of classical mythology for modern culture.
