#### **COURSE PREREQUISITES:**

This course is the continuation of LATI 205, in which students have learned the rudiments of Latin grammar and syntax.

#### **COURSE OBJECTIVES:**

The objective of LATI 207 is to enable students to translate ancient, medieval and modern scientific texts from the original Latin by practicing with actual texts from various disciplines (Mathematics, Medicine, Architecture, Physics, Astronomy, etc.) This course should be of interest to all those concerned with the development of science and technology whether from a historical, scientific or philosophical perspective.

#### BIBLIOGRAPHY

A comprehensive set of selections from Latin scientific literature will be provided.
