Course Description

This course is a reading course focused on the study of Freud's theory of religion. We will meet together to discuss texts written by Freud and about Freud.

Students will be expected to report regularly on the work that they are doing towards their final research project during the second half of the term and to present their conclusions during the final meeting of the term.

Core Competencies

Students will develop the following skills in completing the work for this course:

- •careful and critical reading of texts
- •critical analysis of ideas
- •oral and written communication
- •independent research.

Requirements

50% for attendance and weekly written assignments

- These assignments will be weighted equally in calculating the total of 50% of the final grade.
- One student will write a brief summary of the reading for the week and email it to the other student and the professor at least 24 hours before the scheduled meeting.
- The other student will note important omissions and raise questions about the interpretation presented in the summary.
- Both students will include a section of questions about the text in their written submission, which will include two (or more) well-articulated questions that will be used to facilitate discussion of the text during our meeting.
- You will be assigned one or the other task (summary or response) at least one week prior to each meeting.
- Assignments must be handed in prior to or at the beginning of our meetings. In no case will
 they be accepted afterward as this would defeat the purpose of the assignment, which is
 preparation for discussion.

50% for final essay and presentation of essay in class

- Your research essay, due December 5, is expected to be 12 to 15 pages in length (3600 4000 words). Late essays will be penalized by a decrease of one grade per day (A will be reduced to A-) unless you have received an extension from me.
- You are free to choose any topic relevant to the content of the course but you must obtain my
 approval of your topic and research question. Your paper will not be accepted unless you
 have done so.
- You will be asked to talk about your research throughout the second half of the term and to
 present your conclusions in the final meeting of the course. Failure to do so will result in the
 reduction of a full letter grade (from A to B) of the course grade.
- In grading the essay, I will take into account the sophistication of your research and analysis
 as well as writing style and the use and documentation of sources. Your essay should have a
 bibliography of at least seven sources and include recent articles from academic journals.
- Please use the MLA style of documentation.
- You will be encouraged to present your paper at the U of Lethbridge undergraduate conference in May.

N.B. All written assignments will be assessed with regard to both content (i. e., careful and critical analysis and reflection) and form (i. e., presentation, spelling, grammar, and organization).
