COURSE DESCRIPTION:

Close reading, study, and translation of one play in Greek by the tragedian, Euripides.

This course will take place live and in person. If there are viral troubles it will shift immediately **online** via Desire2Learn (D2L). The course will continue by Zoom.

1. Reading and understanding Greek dramatic poetry.
2. Reading and understanding of Greek accidence and syntax.
3. Reading and understanding of Greek theatre.
4. Understanding of Greek history relevant to the specific play.

We will read all of the trimetre portions of the play, plus the first chorus.

Writing skills include not only surface correctness (grammar, punctuation, sentence structure, etc.) but also general clarity and organization.
