This course will provide a directed reading opportunity in the field of Gender Theory in Late Roman and Medieval Archaeology and History for advanced ANME/GRST students. Students will learn to do advanced research in this field with the end result of the creation of a lengthy piece of scholarship.

2. Learn to do advanced research in medieval studies.
3. Create an advanced piece of research and writing.
