## **Course Description:**

This course covers elements of the Hindu, Buddhist, and/or Jain religious traditions of Asia, with an emphasis on religious doctrine (and less emphasis on religious practice).

### **Course Calendar Statement:**

Introduction to Eastern religions such as Jainism, Hinduism, Sikhism, Buddhism, Confucianism and Taoism.

(\*\*\*Note that the Calendar Statement of this course includes traditions that are not covered in this particular version of the course.\*\*\*)

## **Course Learning Outcomes:**

Students will read and interpret primary South Asian texts in English translation. Students will assess the work of contemporary scholars.

Students will identify themes in South Asian myths.

Students will explain fundamental concepts in South Asian religious traditions.

Students will identify arguments for doctrinal positions within South Asian religious traditions.

Students will synthesize concepts within and across religious traditions.

### **Course Schedule:**

The schedule for this course is divided into weekly modules. Before the first day of class, schedules and material through the first essay will be posted. Before the first essay is due, schedules and material through the second essay will be posted. And before the second essay is due, schedules and material through the final essay will be posted.
