## **Course Description:**

We will be concerned with analyzing concepts of God from a number of religious traditions, in each case considering their philosophical consistency and coherence. The notion of divine transcendence itself will then be interrogated through non-realist theologies, feminist critiques and theories of panentheism, the latter as found in the Hindu theologian Ramanuja's notion of the world as the body of God. Questions we shall have the opportunity to ask include: What is God? How can we legitimately speak of what is by

definition beyond language? How does the notion of God impact religious practice? Is the Goddess transcendent? Can we still do theo-ontology in a post-modern world?

### **Core Competencies:**

Active participants in this course will further their skills in conceptual analysis, collection and evaluation of materials from a variety of methodological perspectives, critical reading and reflection, and effective written presentation of their research and conclusions.
