Course Description:

Comparative study of selected scriptures and related texts in Eastern and Western religions, for the purpose of identifying how scripture functions in a range of religious settings, and to establish a basis for theoretical analysis of the nature of scripture.

Core Competencies:

Students can expect to gain a general understanding of the literary forms, themes, and social contexts of Scripture. The course will contribute to an understanding of the complex cultural processes that produced the category of Scripture, and receive a hands-on experience of the challenges and discoveries that await the patient, critical and open-minded interpreter. A variety of perspectives will be utilized, ranging from the disciplines of Religious Studies to contemporary literary theory and cultural studies. Students interested in understanding the foundations of religions and the role of literary creativity in a religious culture, as well as those with a desire to deepen their insight into the creative collective human imagination in its social context, can benefit from the course.

Course Requirements:

The course will be a combination of lectures and class discussion. The discussion in class will rest on the assumption that students have prepared the selected readings. Each student will be asked to make a ten minute presentation in class of the readings. A 10-page paper is due on August 11. Each student has to meet with me to discuss the topic chosen no later than August 4. The topic has to be submitted for approval, with bibliography, at this meeting. The paper has to reflect the approach, sources, and articles of the course. There will be a **Registrar scheduled final exam**.

Class participation is important to me – and should be to you, too. By class participation I mean: questions asked in class, responses given in class, and knowledge of readings displayed in class discussion (for which I will keep written track).

Class participation will account for 15% of the grade, presentation for 15%, topic submission for 10 %, paper for 30 % and the exam for 30 %.
