Course Description

A study of rhetorical thought and action from the classical period to the modern age, with an emphasis on the interaction between rhetoric and philosophical, social, and political change. Theories will be applied to the criticism of historical and contemporary public communication. Prerequisite: COMS 369.

Objectives of the Course

- To understand the history of rhetoric in its social context from the classic to the contemporary period
- To gain competence in rhetorical analysis of texts, media and their contexts
- To apply rhetorical principles to the processes of composition and performance

Internet and electronic communication device information

During student presentations, the use of electronic devices is not permitted. At other times, use electronic devices for course related functions only. Assignments and Evaluation

Critical Essay 20% Outline: Wed. Jan 30 / Final: Wed. Feb 13 - This 2000-word essay will employ concepts from Classical rhetoric to reveal the rhetorical situation and argumentation of an artifact that has been published freely online by a Canadian person, group, or organization within the past five years.

Presentation 10% As scheduled

- In 10-15 minutes, present and critique a short public online rhetorical artifact created in Alberta or by Albertans. In your criticism, use one or more concepts discussed in the assigned readings of the week. Submit a presentation outline and/or slides to the online peer review forum before class begins on your presentation day. Bring paper copies of a basic 1-2 page outline for the instructor and your peer reviewers to take notes.

Midterm Exam 15% Friday, March 1

- This exam will be held during 50 minutes of class time. It will focus on concepts from textbook chapters assigned prior to the exam. Short-answer questions will ask you to identify, define, explain, apply or discuss concepts, quotations, or rhetoricians.

Final Essay 30% Draft: Wed. Mar 27 / Final: Fri. Apr 12

- Write a 2000-word essay combining elements of rhetorical history, theory and criticism. Your topic, approved by the instructor, should be different from your first essay. Append to the final version a 1000-word reflective essay that uses rhetorical principles to discuss your own writing and research process and your essay's major rhetorical features.

Final Exam 10% Wednesday, April 10

- This exam will be held during 50 minutes of class time. It will focus partly on concepts from chapters assigned since the midterm. A portion of the exam may consist of a brief rhetorical analysis of a text or visual provided in the exam materials.

Peer Reviews 15% Wed. Feb. 6 and April 3

There are three components of the peer review score:

1. Complete, timely, and well-prepared drafts or outlines, 5%. In order to undergo peer review on the designated dates above, students will submit online to the peer review forum 1) an abstract and outline of the critical essay by Jan. 30, and 2) a full draft of the final essay by Mar. 27. Outlines or drafts must be submitted on time and meet length and

format standards. In your outline or draft, include a link to the artifact you are critiquing. The abstract is a 200-word paragraph summarizing your essay. The outline should include your essay's main arguments in full sentences and sub-points in point form. The complete draft of the final essay should have a full introduction, include all major headings or components, and should be at least 70% of the required final length.

- 2. Essay peer reviews, 5%. Students will be assigned to peer review groups of 4-5 students and review two designated peers' outlines or drafts on each peer review day. Each student will come to class on Feb. 6 and Apr. 3 prepared for peer review. Student groups will provide each other with writing feedback and advice while the instructor circulates the room. Students will also review one of their peers' final essay drafts in a 250-word peer review letter posted online on the peer review forum by April 3. Within two days after peer review days, post on the forum a brief message about what you learned from the peer review experience, and any plans for writing or revision.
- 3. Presentation peer reviews, 5%. Students will sign up for peer reviews of 2 student presentations during the term. Reviews should be at least 250 words each and in complete sentences, should cover content, organization, style and delivery, and should be posted online in the peer review forum within two business days after the presentation.

Each of the sub-components above will be noted as complete/incomplete during term. Formative instructor feedback may be provided occasionally as time permits, or during an appointment. After the end of classes the components will be scored for quality, completeness and timeliness.

Assignment submission

All assignments will be submitted online and graded online. Do NOT email your assignments directly to the instructor. Submit your assignments online via the course management system, Canvas, as instructed, in .doc, .docx or pdf file format.

It is the student's responsibility to verify online submission and to keep a secure backup copy of each submitted assignment. After submitting a file, download your file from the course management system and open it to verify that it is the correct version and there were no file transfer errors. If Canvas is not working, submit your assignment to the course's drop box on Blackboard and notify the instructor. If internet access is unavailable, submit in paper within the grace period. SS320 has a stamp and sign-in system for assignment submission, and an after-hours drop box in the wall. *Re-submit the assignment electronically via Canvas as soon as possible when access is available*.

Assignment deadlines

Presentation materials, Outlines, Drafts, Peer Reviews, etc. must be submitted online to the appropriate online discussion forum before the beginning of a class (12:00PM).

Essay final versions are due online by 11:59PM on their deadline. A grace period of 12 hours is allowed for unanticipated technical difficulties, short-term illness, or unexpected scheduling challenges. A student is automatically permitted a 48-hour deadline extension if his/her Presentation is scheduled on a day when an Essay's final version is due.

Policy for Late Assignments

Late assignments may be penalized with the loss of a grade (e.g.: A- to B+) for each day late. For peer review components, a late penalty may apply for each late item. Documentation may be required to waive late penalties.

Freedom of Information and Protection of Privacy Act

This course is conducted in accordance with the Freedom of Information and Protection of Privacy Act (FOIP). As one consequence, *students should identify themselves on all written work by placing their name and ID number on the first page of the final version*. (However, please do not place your ID number on drafts and messages posted on the class discussion board.) You will also be required to provide a piece of *picture identification* in order to pick up an assignment or look at a final exam from SS320 after classes have ended. Where a grade on a particular assignment is expressed as a letter grade, it will normally be converted to a number using the midpoint of the scale. That is, A- would be converted to 87.5 for calculation purposes. F will be converted to zero.

Plagiarism

Using any source whatsoever without clearly documenting it is a serious academic offense. Consequences include failure on the assignment, failure in the course and possibly suspension or expulsion from the university.

You must document not only direct quotations but also paraphrases and ideas where they appear in your text. A reference list at the end is insufficient by itself. Readers must be able to tell exactly where your words and ideas end and other people's words and ideas begin. This includes assignments submitted in non-traditional formats such as Web pages or visual media, and material taken from such sources.
