Course Description

An introduction to the main issues involved in studying and analyzing film including medium, story, photography, mise-en-scene, movement, editing, sound, and acting. Intended to prepare students for further work in film studies. Antirequisite: Credit for both FILM 200 and FILM 201 will not be allowed.

This course introduces basic concepts of film analysis, which are discussed through examples from different national cinemas, genres, and directorial oeuvres. Along with questions of film technique and style, we consider the notion of the cinema as an institution that comprises an industrial system of production, social and aesthetic norms and codes, and particular modes of reception.

Additional Information

Attendance at lectures, screenings and tutorials, and informed participation are essential components of this course and will help determine your final grade. Students must come to class prepared to discuss the required reading. Some of the materials and topics presented in class may include explicit content (sex, violence or language). If these materials make you uncomfortable, you are encouraged to speak with the professor. You

will not be exempt from any class assignments but we will work together to accommodate your concerns.

IMPORTANT: Students **MUST** be registered for three different sections of FILM 201-01. **L-01** refers to the lecture section, which is scheduled consecutively on Wednesday evening with **T-01**, the screening time. In addition, students should enroll in one of the tutorial sections, **B-01-06**, which are held on Thursday evenings and on Friday mornings.

Objectives of the Course

Here we will set a simple, yet ambitious, objective. As an introductory-level course in film studies, we will learn the fundamental ideas and theories of film analysis. There is much ground to cover; by the end of the course students will be conversant in the language and theory of film study. Students will apply their theoretical understanding of film to the production of critical analysis.

At the conclusion of this course, students will be able to:

- Produce a sustained written analysis that incorporates ideas that are introduced during the course
- Demonstrate their mastery of the critical concepts introduced in the course by producing a formal analysis that correctly employs relevant terminology as necessary
- Write a term paper that follows all appropriate academic protocol

The participation grade for this course will be assessed in two equal measures. First, students will be evaluated on their active and informed participation in weekly tutorial sections. Secondly, students will be required to write three response essays (250-300 words) relating the films screened in class to the material covered in lecture and in the readings for that week. Films are screened at the conclusion of lecture on Wednesdays; these essays are due prior to the beginning of your tutorial sections and should be submitted via Blackboard.

April 12 Final Paper (1000-1500 words) 25% *The final paper will be a sequence analysis, using the tools and vocabulary that we have* developed over the course of the semester. More information will be provided when the assignment for this paper is handed out, after the mid-term.
