## **Course Description**

Topics will focus on the style, narrative form, and historical evolution of selected genres, for example, the Documentary, the Western, the Melodrama, the Musical, etc. This course may be repeated for credit.

# **Objectives of the Course**

John Grierson may have been the first to offer a definition of documentary film, in the 1920s, but the documentary impulse has been present in the cinema since the very first frames of motion pictures were projected in the 1890s. From the *actualité* films of the Lumières in the 19<sup>th</sup> century to reality television in the 21<sup>st</sup>, the "creative treatment of actuality"—Grierson's famous definition of the documentary—has provided one of the most enduring, and yet enigmatic, goals of film and media makers across the globe. In this course, we will survey the history of documentary cinema, concentrating primarily on the documentary feature film and its evolution over the decades. Students will be introduced to a variety of theoretical approaches for understanding documentaries, and will explore the technological, cultural, economic, and political history of the medium.

At the conclusion of this course, students will be able to:

- Produce a sustained written analysis that incorporates ideas that are introduced during the course
- Demonstrate a mastery of the theoretical and historical issues covered in the course, as well as an engagement with the films screened in the course
- Write a term paper that follows all appropriate academic protocol

#### **Additional Information**

Attendance at lectures and screenings and informed participation are essential components of this course and will help determine your final grade. Students must come to class prepared to discuss the required reading. Some of the materials and topics presented in class may include explicit content (sex, violence or language). If these

materials make you uncomfortable, you are encouraged to speak with the professor. You will not be exempt from any class assignments but we will work together to accommodate your concerns.

#### **Internet and electronic communication device information**

Students are welcome to use laptops and other electronic notetaking devices in this course. That being said, the classroom is a space for learning, and I expect that students' behaviour will reflect a shared appreciation for the importance of an open and high-level discourse within the classroom. # **Assignments and Evaluation**

<u>Assignment</u> <u>Weight</u>

Participation 10%

Students are expected to regularly attend class and actively participate in class discussions. Full marks will be given to students who regularly demonstrate through their participation in class discussions an engagement with the course readings and screenings.

Midterm Exam 35%

Students will write the mid-term examination in class on **February 28**. The multiple-choice and short answer exam will be drawn from the readings, screenings, and lectures covered during the first six weeks of class.

End-of-Term Ouiz 20%

Students will write a quiz in class on March 28. This multiple-choice and short answer quiz will cover the readings, screenings, and lectures introduced after the mid-term (i.e., it is non-cumulative).

Final Paper (1250-1750 words)

35%

Students are required to write a final paper for the course, following guidelines that will be distributed in class. The expectation is that the student's argument will reflect a

significant degree of engagement with existing scholarly literature, and/or a demonstration of significant original research.

Papers are due on the last day of the term (April 16), and should be submitted via the course website.

It is the student's responsibility to keep a copy of each submitted assignment. Note: Please hand in your essays directly to your tutor or instructor if possible. If it is not possible to do so, a daytime drop box is available in SS320; a date stamp is provided for your use. A night drop box is also available for after-hours submission. Assignments will be removed the following morning, stamped with the previous day's date, and placed in the instructor's mailbox.
