**Course Description**

An examination of the movies of celebrated American filmmaker Howard Hawks.

**Objectives of the Course**

Through an exploration of Hawks' (1896-1977) diverse body of work, which spanned nearly six decades, students will be introduced to and have the opportunity to consider and debate key ideas in cinema studies, including those centered around questions of authorship, genre, gender, and industry. Ultimately, students will demonstrate the ability to mobilize these ideas in the perceptive and critical analysis of the work of a single filmmaker.

In order to achieve these objectives, it is imperative that students come to class prepared, having completed the assigned readings or other preparatory tasks and willing to discuss pertinent issues with both the instructor and their peers in a thoughtful and respectful manner.

**Assignments and Evaluation**

- 20% 2,000-word essay due 2/7. A list of topics will be provided.
- 20% Final essay, part one: essay outline, filmography, and annotated bibliography of five sources, due 3/6. A list of suggested essay topics will be provided, but students may elect to develop their own topic in consultation with the instructor.
- 20% Final essay, part two: in class research presentation on 4/3, 4/5, 4/10 or 4/12.
- 30% Final essay, part three: 3,000-word research essay, due 4/19 (one week after the final class)
- 10% Weekly participation. Be advised that simply being physically present in the classroom *does not* constitute participation.

If you are going to miss class, you must let the instructor know ahead of time by email. Students are responsible for catching up on any material missed due to absence.

All assignments must be composed in formal, academic English, and formatted according to either MLA or Chicago documentation and presentation standards. Your name and student number must appear on each page. Please staple all work – no paper clips or folders.

In cases of illness or bereavement, late assignments will only be accepted if accompanied by official documentation (e.g. a note from your physician). All other late assignments will be penalized according to the policy detailed below.

It is the student's responsibility to keep a copy of each submitted assignment.

Note: Please hand in your essays directly to your instructor if possible. If it is not possible to do so, a daytime drop box is available in SS320; a date stamp is provided for your use. A night drop box is also available for after-hours submission. Assignments will be removed the following morning, stamped with the previous day's date, and placed in the instructor's mailbox.

### **Plagiarism**

Using any source whatsoever without clearly documenting it is a serious academic offense. Consequences include failure on the assignment, failure in the course and possibly suspension or expulsion from the university.

You must document not only direct quotations but also paraphrases and ideas where they appear in your text. A reference list at the end is insufficient by itself. Readers must be able to tell exactly where your words and ideas end and other people's words and ideas begin. This includes assignments submitted in non-traditional formats such as Web pages or visual media, and material taken from such sources.
