Course Description

An examination of the diverse ways in which film criticism and scholarship has grappled with the enduring concept of genre. The course will be organized around five topics: the structure and form of genres; the purpose of genres; the relationship between individual films and their genre(s); genre history; and genre in national and transnational contexts.

Objectives of the Course

Through a close engagement with seminal philosophical, scholarly, and critical writing, students will acquire an advanced theoretical and historical understanding of “genre” as an analytical concept that can be used to categorize, examine, and understand cinema.

In order to achieve this objective, it is imperative that students come to class *prepared*, having completed the assigned readings or other preparatory tasks and willing to discuss pertinent issues with both the instructor and their peers in a thoughtful and respectful manner.

Assignments and Evaluation

- 25% 3,000-word essay due 10/17. A list of topics will be provided.
- 30% In-class presentation in week 12 or 13 (11/28, 11/30, 12/5, 12/7).
- 35% 5,000-word essay due during the first week of the examination period (date TBD). A list of suggested topics will be provided, but students may elect to develop their own topic in consultation with the instructor.

10% Participation. Be advised that simply being physically present in the classroom *does not* constitute participation.

Students are responsible for catching up on any material missed due to absence.

All work submitted for evaluation must be composed in formal, academic English, and formatted according to MLA documentation and presentation standards. Your name and student number must appear on each page. Please staple all work – no paper clips or folders.

All assignments must be handed in at the start of class on the day on which they are due.

In cases of illness or bereavement, late assignments will only be accepted if accompanied by official documentation (e.g. a note from your physician). All other late assignments will be penalized according to the policy detailed below.

It is the student's responsibility to keep a copy of each submitted assignment.

Plagiarism

Using any source whatsoever without clearly documenting it is a serious academic offense. Consequences include failure on the assignment, failure in the course and possibly suspension or expulsion from the university.

You must document not only direct quotations but also paraphrases and ideas where they appear in your text. A reference list at the end is insufficient by itself. Readers must be able to tell exactly where your words and ideas end and other people's words and ideas begin. This includes assignments submitted in non-traditional formats such as Web pages or visual media, and material taken from such sources.
